

# BRYANT RANCH STALLION BREEDING CONTRACT

I hereby agree on \_\_\_\_\_ (date) to breed the mare \_\_\_\_\_, Registration # \_\_\_\_\_, to the Stallion **Rawhide Dunit**, Registration # 5331952, for the 20\_\_ breeding season. The Stallion Fee is \$600.00, including a non-refundable booking fee of \$100.00 which shall be payable upon execution of this contract. \*\*Stud Fee is \$500.00 if booked prior to February 1<sup>st</sup>. Mare will be bred (check one): On site at Bryant Ranch \_\_\_\_ or with Shipped Semen \_\_\_\_.

- BREEDING SEASON:** It is understood that the breeding season for Bryant Ranch begins on January 1<sup>st</sup> and terminates on July 1<sup>st</sup> of the same calendar year. Mares not settled within said breeding season shall be carried over to the subsequent breeding season.
- ON-SITE BREEDING:** The Stallion Fee shall be payable in full when the mare is pronounced in foal, or when the mare is picked up from Bryant Ranch, after having been exposed to the stallion. All other expenses, including boarding, shall be paid in full when the mare is picked up from the breeding facility.
- FOR COOLED/FROZEN SHIPPED SEMEN:** The Stallion Fee stated above is due and payable upon execution of this contract and at least ten (10) days prior to ordering semen. Mare Owner is responsible for all facets of breeding the Mare and agrees to comply with the related breed association requirements concerning the use and handling of cooled and/or frozen semen. Mare Owner agrees that an individual who is qualified and experienced in the use of handling cooled and/or frozen semen will perform the insemination procedure within 24 hours, but not more than 48 hours after collection of the Stallion. Mare owner agrees to use all semen provided by this contract for the mare named in this contract and no other.
- COOLED/FROZEN SEMEN SHIPMENT FEES:** A fee of \$300.00 will be charged for each shipment of cooled semen. A fee of \$350.00 will be charged for each shipment of frozen semen. An additional fee of \$1,500.00 will be charged to the Mare Owner if the frozen semen shipping container is not returned in 30 days. Mare Owner agrees to return shipping container to Bryant Ranch at the expense of the Mare Owner. ***A request for a shipment of cooled semen must be made 24 hours prior to needing semen shipped.*** Cancellations must be made by 8:00 pm prior to the day of shipment. Mares on the premises of Bryant Ranch have a breeding priority on any given breeding day, therefore, we make no guarantee cooled semen will be available on any given day. All fees and charges due must be paid in full prior to any request for shipment. Upon receipt of shipment, Mare Owner shall try diligently to settle the Mare and shall use all diligence and care in the insemination of the Mare. Shipping Days are Monday, Wednesday and Friday (excluding holidays).
- LIABILITY:** Mare Owner waives all claims against Bryant Ranch for the sickness, injury, or death of the Mare and her offspring arising from the exercise of the breeding/ultrasound privilege granted in this contract. Bryant Ranch waives all claims against Mare Owner for any injury, sickness, disease or death of the Stallion arising from the exercise of the breeding privilege granted in this contract.
- BOARD & VETERINARY CHARGES:** (applicable to on-site breeding's only) Bryant Ranch agrees to provide suitable facilities for the care and feed of the mare and/or foal while in their custody. The Mare Owner agrees to the rates in the fee schedule above. Mare Owner agrees to pay all board and other veterinary/ultrasound expenses incurred by the Mare and/or foal while in the care of Bryant Ranch, and these expenses are due and payable before the Mare and/or foal depart from Bryant Ranch. The Mare and/or foal will not be released until all fees are incurred on behalf of the Mare and/or foal have been paid in full. The Breeders Certificate for the

breeding stated in this contract will not be issued until the Mare Owner has paid all the fees and expenses incurred on behalf of the Mare and/or foal.

7. **CONDITION & TREATMENT:** Mare Owner agrees that when delivered to Bryant Ranch, or when semen is ordered for shipping, the Mare will be healthy and in sound breeding condition. A copy of the Mare's registration papers must accompany this contract. If the Mare is to be bred at Bryant Ranch, then Mare Owner will also provide Bryant Ranch with a negative Coggins dated within 12 months prior to delivery of the Mare and/or foal to the Ranch.
8. **CARE OF MARE & FOAL FOR ON-SITE BREEDING:** Bryant Ranch shall exercise reasonable judgment in the breeding, care, and supervision of the Mare. Bryant Ranch shall diligently try to settle the Mare. The Mare Owner agrees to give Bryant Ranch ample opportunity to settle the mare (having bred her thru two (2) heat-periods). The Mare Owner agrees to give Bryant Ranch and the attending veterinarian permission to do what is needed to settle the mare. If for any reason a Mare does not settle, Mare Owner waives any claim against Bryant Ranch. If after 2 heat-periods, mare does not settle, Bryant Ranch's veterinarian will examine the Mare for normal breeding conditions and will administer care for the Mare that the veterinarian deems necessary. Mare Owner grants Bryant Ranch the right to exercise all reasonable authority with respect to the care of the Mare and/or foal. Bryant Ranch shall attempt to contact Mare Owner by telephone prior to taking any actions that are not an emergency. Bryant Ranch reserves the right to refuse any mare that is not in proper condition or which does not have all of the documents as required herein.
9. **EMBRYO TRANSFER:** If more than one embryo is produced from a Stallion breeding under this contract, and if multiple embryos are transferred, then the Mare Owner must notify Bryant Ranch of the transfer of embryo(s). If embryo transfers result in multiple pregnancies, then Mare Owner must pay Bryant Ranch the Stallion Fee for EACH pregnancy.
10. **LIVE FOAL GUARANTEE:** Mare Owner agrees to have said mare pregnancy checked within forty-five days from the date of the last breeding and provide said information to Bryant Ranch within five days from the date of said pregnancy check. Mare Owner shall have a guaranteed right to rebreed during the subsequent breeding season. "LIVE FOAL" means that the foal resulting from the breeding stands and nurses without assistance and lives for 48 hours. This return breeding privilege is conditioned upon Mare Owner giving Bryant Ranch notice within 7 days after the foaling or aborting that the Mare did not produce a live foal.
11. **BREEDERS CERTIFICATE:** A Breeders Certificate will be issued for the foal conceived by the mating when the Stallion Fee and all other expenses incurred by the Mare and/or foal have been paid in full.
12. **TERMINATION:** If the Stallion dies, is sold, or becomes unfit for breeding, this contract will immediately terminate. The Stallion Fee will be refunded, and Bryant Ranch and the Mare Owner will be released from any further obligation under this contract.
13. **The parties acknowledge that this contract is made in the State of Oklahoma and shall be construed and enforced under the laws of the State of Oklahoma.** (UNDER OKLAHOMA LAW, AN EQUINE PROFESSIONAL IS NOT LIABLE FOR AN INJURY OR THE DEATH OF A PARTICIPANT IN EQUINE ACTIVITIES RESULTING FROM THE INHERENT RISKS OF EQUINE ACTIVITIES).
14. This contract shall be binding upon the parties hereto, upon execution hereof, and the same may not be altered or amended, except by written mutual consent of the parties hereto.
